

CONSIGNMENT #: 5057 **VIN #:** 8039 Ferrari buyers have long ranked among the most demanding of their cars and while legendary American Ferrari distributor Luigi Chinetti certainly admired the new 275 GTB, he was less than impressed with the conservatively styled open GTS model. Accordingly, following discussions with Enzo Ferrari and the Scaglietti coachworks, Chinetti commissioned the achingly beautiful open version of the 275 GTB, known as the "N.A.R.T. Spider," so-named after his famous North American Racing Team. As many as 25 examples were envisioned, but ultimately just 10 were built, with the visual and performance appeal of Chinetti's inspired creation drawing strong demand among Ferrari connoisseurs that continues even stronger today. According to Ferrari experts, 15 original 275 Berlinettas were converted by custom coachbuilders to N.A.R.T. Spider form.

This outstanding example, numbered 08039, is an original 275 GTB that was completed in April 1966. A highly desirable long-nose, "Interim" driveshaft model, it was an original left-hand drive, two-cam, triple-carburetor model and delivered via official French Ferrari distributor Franco-Brittanic Autos when new to its first owner in France. Of course, 8039 GT is listed in the second edition of Hilary A. Raab's "Ferrari Serial Numbers Part I."

Recently, the 275 received a complete professional service including the brakes, plus attention to the leather upholstery, with a fully-detailed invoice on file confirming the works performed. Retaining its matching numbers engine, offered complete with import and title paperwork, and simply beautiful in presentation with excellent care and storage clearly evident, this highly desirable N.A.R.T. Spider conversion is both a wonderful example of the legendary Ferrari 275 and a testament to its coachbuilder's artistry, in the most highly desirable open-air form.

CONSIGNMENT #: 5044 VIN #: P538002-LMA Known as the "Father of the 250 GTO", Bizzarrini was also a refugee from Ferrari in the wake of the infamous November 1961 "Purge" or "Palace Revolt" at Modena. He worked with the brilliant but short-lived ATS concern, designed the innovative Piero Drogo-bodied 250 SWB "Breadvan" for Count Volpi of Scuderia Serenissima, and he gave the world the original DOHC Lamborghini V-12 engine, as well as the Iso Rivolta and Grifo, and the Bizzarrini A3C and 5300 GT, culminating in his four P538 competition cars of the mid-1960s, with one contesting the storied 24 Hours of Le Mans in 1966 before open prototypes were declared ineligible for 1967.

Fast-forward to 2005. To commemorate both his upcoming 80th birthday and the 40th Anniversary of the debut of the P538 in 2006, Giotto Bizzarrini was encouraged by Dutch Bizzarrini experts and historians Jack Koobs de Hartog and Peter Opper to build a run of just three new cars based on the P538 to be dubbed "P538 Le Mans Anniversario." While no trace of the original P538 technical drawings remained, Sig. Bizzarrini produced new ones from memory and with the assistance of a few period photographs, with the Anniversario cars hand-built by Giotto Bizzarrini at his Scuderia Bizzarrini premises in Rosignano, Italy. Wife Rosanna helped lay out the fiberglass bodies, using the original moulds supplied by the Vincenzo Catarsi works during the 1960s, and Mr. Bizzarrini himself, who displayed joy and virtually indefatigable energy in the completion of the historic project, constructed the entire chassis for each car.

Following completion of the three P538 Le Mans Anniversario cars in 2009, Sig. Bizzarrini closed Scuderia Bizzarrini and retired for good. Thankfully, the P538 Le Mans Anniversario venture was fully and lovingly documented in the book "Bizzarrini P538 Anniversario: A Tribute to a Genial Engineer and Feared Entrepreneur," by Jack Koobs de Hartog. As one of the final three cars ever to be constructed by the hand and fertile mind of Giotto Bizzarrini, this example is spectacular and almost otherworldly in its purposefully aggressive styling and race-bred performance. As such, its offering at Monterey will certainly provide a most fitting tribute to its inspired creator, Giotto Bizzarrini, who is still rightly known as "L'Ingegnere."

This historic automobile is a particularly striking example of Ferrari's very first road-going Sports/GT series, the 166 Inter. Only 37 were produced in total from 1947 to 1953, with all built as bare chassis by Ferrari and cloaked in custom bodywork by a number of Italy's renowned coachbuilders of the era. Just eight of them – exemplified by the striking Berlinetta offered here, numbered 037 S – were fitted with elegant yet sporting coachwork by the house of Stabilimenti Farina.

A development of the competition 125 S and 166 S models and sharing their basic Aurelio Lampredi tubular-chassis design in common, the 166 Inter was a thinly disguised racing car for the road, as Enzo Ferrari was not yet committed to the idea of series-production road-cars. In typical Ferrari fashion, its "166" model designation denoted the swept volume of each of the Gioacchino Colombo-designed 2.0-liter engine's 12 cylinders. The "Inter" moniker was bestowed upon it in tribute to the racing victories earned by Scuderia Inter for Ferrari with the 166 S during the late 1940s. This stellar image, plus Clemente Biondetti's 1948 Mille Miglia win and Luigi Chinetti's heroic 23.5-hour drive to victory at Le Mans in 1949, sealed the outstanding race-bred credentials of the 166 Inter road cars.

This wonderful example is the 16th of the series produced according to its 037 S chassis number and Ferrari's road-car numbering conventions. Early in its life, the original engine, also numbered 037 S, was given a displacement increase to the 2.5-liter engine specification of Ferrari's subsequent 212 model, and it is believed that the car's original single twin-choke carburetor was upgraded to the present triple twin-choke intake system at that time as well. Sold new in June 1949 in Rome to one Mr. Tamorri, 037 S was eventually exported to the USA in the 1950s and in 1987, it was acquired by the UK's Lord Charles Brocket and then sold to Peter Agg, who invested over \$240,000 into its top-quality restoration.

CONSIGNMENT #: 5002 **VIN #:** CSX2012 Offered for sale for the first time since acquired by the current owner in 1984, the legendary early-production Cobra offered here, numbered CSX2012, is extremely significant in the Shelby pantheon as the first Cobra ever sold to a customer. Accompanied by fully documented history with just four owners from new and three of them for the long term, CSX2012 was part of Shelby's initial 100-car contract with England's AC. It was invoiced to Shelby American on September 26, 1962, shipped by sea to Shelby American at Los Angeles, and originally finished in Red with a Black interior and equipped with a Harrison aluminum radiator, front and rear anti-sway bars, seat belts, and a set of Goodyear racing tires. On November 12, 1962, Robert and Sylvia Neville, who were friends of Carroll Shelby, purchased the Cobra.

The Nevilles returned the car to Shelby American in January 1963 to have the Cobra's originally-installed 260 V-8 replaced by Ford's larger, more powerful, and newly-available High-Performance 289. In addition, a set of back-up lights was installed, custom-made using a set of clear Lucas parking-light lenses. Soon after, Neville drove CSX2012 on a long-range public relations trip from Los Angeles to Sebring, Florida to "demonstrate its practicality." A photograph of the Cobra from this moment in time was recently published in 2009's "The Complete Book of Shelby Automobiles: Cobras, Mustangs, and Super Snakes" by Colin Comer, with CSX2012 shown equipped with the aforementioned Goodyear Blue Streak tires, plus sun visors, wind wings, and exhaust pipes exiting in front of the rear tires.

During the early 1970s, the Nevilles advertised CSX2012 for sale with a stated 12,000 miles. Interestingly, the ad also stated the Cobra's cylinder heads had been ported by none other than Californian racing legend Joe Mondello, whose achievements included his work on the 289 V-8s that helped Shelby American and co-drivers Dan Gurney and Bob Bondurant take first in class at Le Mans with a Shelby Daytona Coupe in 1964. As recently photo-documented, the cylinder heads continue to bear the stamping "Mondello's Porting Service" on the intake side.

CONSIGNMENT #: 5001 **VIN #:** SCCA 81 144 Following Group 44's 1975 SCCA B-Production National Championship and back-to-back Trans-Am championships in 1977 and 1978, Jaguar commissioned a new XJS "silhouette" car to be built and campaigned by Group 44 for the 1981 Trans-Am series. Unlike its forebears, the new XJR-4 was a purpose-built, fully tube-framed car with fabrication directed by "Lanky" Foushee and a race-prepped Jaguar V-12 powering it. During the hard-fought 1981 Trans-Am season, Bob Tullius put the XJR-4 onto the podium in second at the car's first race at Charlotte. Three outright victories were scored at Portland, Brainerd, and Mosport. Just two points separated Tullius and the XJR-4 from the Championship.

Next, the XJR-4 was entered by Group 44 into the 24 Hours of Daytona, a moment in time foreshadowing Jaguar's eventual full-scale return to international endurance racing. Deemed too radical for GTO, the XJR-4 was moved up into GTP-GTX, pitting it against far faster prototypes and effectively putting XJR-4 out of contention for victory. Nonetheless, Tullius and tire sponsor Goodyear used the race as an endurance test for Goodyear's new Wingfoot performance tires (shaved for racing) during the race. The XJR-4 and its drivers Bob Tullius, Canada's Bill Adam, and Gordon Smiley acquitted themselves well, with the car going the full 24 hours and becoming famous as the "World's Fastest XJS" for hitting 194.46 mph at Daytona - on street tires no less!

Next, the XJR-4 was sponsored by Intermedics and intended for Gordon Smiley to drive in the 1982 Trans-Am series. Following Smiley's tragic death during practice at Indianapolis, Tullius drove the XJR-4 in its last Trans-Am start at the first race at Road Atlanta.

With their achingly beautiful bodylines and openair configuration, demand for them predictably continues to outstrip available supplies, spurring demand for expert conversions of the basic 365 GTB/4 to glamorous open Spyder form. This outstanding example, S/N 15689, was built in July 1972 as an original European-specification model. It is one of only two 365 GTB/4s rebodied at extra cost with a full-alloy-body Spyder conversion by Carrozzeria Auto Sport of Modena, Italy. To Ferrari cognoscenti, Carrozzeria Auto Sport was founded in 1972 by Franco Bacchelli, who began his career during the late 1950s at Piero Drogo's Carrozeria Sports Cars in Modena, and Roberto Villa, an aluminumforming expert from Carrozzeria Scaglietti. In short, to say that experts performed the full-alloy Spyder conversion of 15689 would be a massive understatement.

In addition, 15689 is even more desirable with its V-12 engine and gearbox having been rebuilt to Competition 'Daytona' specifications during the late-1990s/early 2000s by a former Chinetti N.A.R.T. team mechanic who was then based in Torino, Italy. It was also fitted with six Weber carburetors. Fitted with factory power steering from a 365 GTC/4, it is also particularly user-friendly and easy to drive with a desirably light steering feel.

As offered, 15689 offers an exceptional ownership experience to match its wonderful open-air panache. It is accompanied by over 35 years of detailed ownership history since importation to the USA in 1977, including expert mechanical maintenance without regard to cost. In addition to its competition-spec six-carburetor engine and gearbox, the 'Daytona' is further equipped with Borrani 8- and 9-inch wire wheels with Michelin XWX tires and complete with a very nice reproduction owner's pouch with owner's handbook, plus an original tool roll including some original tools and some reproduction tools.







CONSIGNMENT #: 5056 **VIN #:** 4975GT Long respected as one of the finest and most practical road cars offered by Ferrari during the 1960s, in basic essence combining the handsome Pininfarina styling of the 250 GT 2+2 with a noticeable performance boost from the larger Tipo 209/B four-liter V-12 delivering 300 hp. The 330 America 2+2 is also one of the rarest Ferrari road cars with a limited run of just 50 examples produced briefly during 1963.

The vast majority of the cars, in keeping with their "America" moniker, were imported to the USA by Luigi Chinetti Motors in Connecticut, including this outstanding example, numbered 4975 GT. According to its known history, the 330 America was sold new to one R. Aldeb and then in February 1974, it was sold to Richard Pessin, the brother of 'Bud' Pessin, a Ferrari dealer located in Missouri, and retained by him until September 2000. In March 2000, 4975 GT was sold to Miles Irish of Palos Verdes, California, and reported to have been very nice at the time. In February 2002, the car received comprehensive mechanical work and sorting by the experts at FAI in Costa Mesa, California, and then in 2002, 4975 GT took its place within the impressive personal collection of its current owner.

As offered, 4975 GT clearly benefits from proper care and storage and features a wonderful Ruby Red exterior finish, complemented by Tan leather upholstery piped Red. The engine remains very strong, and the car continues to benefit from a concours-level detailing. Borrani wire-spoke wheels provide a finishing touch. An elegant and crisply styled, yet sporting classic Ferrari 2+2 and the fourth of just 50 originally built, 4975 GT is simply one of the finest and best-performing road cars of the 1960s and simply put, it represents a wonderful and rare offering at auction today.

CONSIGNMENT #: 5043 **VIN #:** 07774 001 Following his departure from Ferrari during the infamous November 1961 "Purge" or "Palace Revolt" at Modena, Bizzarrini's fertile mind and intense work ethic continued to rewrite racing history. He worked with the brilliant but short-lived ATS concern, designed Piero Drogo-bodied 250 SWB "Breadvan" for Count Volpi of Scuderia Serenissima, which continues to appear on vintage-racing grids today, and he designed the original DOHC V-12 engine for Ferari rival Ferruccio Lamborghini. He fulfilled the automotive ambitions of yet another successful post-war Italian businessman by developing the Iso Rivolta and Grifo GTs for Renzo Rivolta. Bizzarrini eventually focused on designing competition cars for himself, including the A3C and 5300 GT, and then his four P538 competition cars of the mid-1960s, with one contesting the storied 24 Hours of Le Mans in 1966 before open prototypes were outlawed for 1967.

While the above succession of designs are among the bestknown examples of Bizzarrini's work, he also designed the fascinating "one-off" monoposto offered here, which teased the motoring press, including Road & Track, in 1966 with its all-out F1-style chassis and layout. Powered by a hot yet reliable 420-hp Chevrolet 327 V-8, with which Bizzarrini was very well acquainted, and mated with a ZF gearbox at the rear, the car was intended for a wealthy client to race in European hillclimb events. According to legend, however, the buyer was not prepared for the car's ferocious acceleration capabilities and it reportedly frightened him so badly that the car was immediately returned to Bizzarrini. It fell from sight and was sold from the Bizzarrini dispersal auction in the early 1970s. It has since been restored and remains striking in every respect, with a recent appearance at the 2010 edition of Concorso Italiano. As offered today, this "one-off" monoposto provides a highly stirring reminder of its creator's legendary engineering prowess and ability to design specific and highly competitive cars for any given purpose.

Created and released for just one purpose - to homologate Ford's hot new Boss 429 engine for NASCAR Grand National competition - the "Boss Nine" was essentially hand-built by Ford subcontractor Kar Kraft of Brighton, Michigan. Extensive modifications to the Mustang's basic chassis were required to accommodate the big Boss, including the cutting and relocation of the front shock towers. A complete package, the Boss 429 included such special high-performance features as a stout "Toploader" close-ratio four-speed transmission, 9-inch Traction-Lok rear end, 3.91:1 gears, engine-oil cooler, trunk-mounted battery, competition suspension with front and rear anti-roll bars and staggered rear shocks, power front disc brakes, chrome Magnum 500 wheels, and fat F60 X 15 tires. Laughably, Ford rated output of the "street" Boss 429 Mustang at 375 hp, a figure that hardly explained the car's ability to cover the quarter-mile in the 12-second range with only a few minor modifications. On NASCAR ovals, the Boss 429 engine powered David Pearson to his third championship during Ford's dominant 1969 racing season.

The most expensive Mustang of its era, the hairy Boss 429 was predictably rare when new, with just 859 built for 1969 (including two Boss-Cougars). Finished in Wimbledon White and numbered KK 1785, this example features a Black Deluxe interior and it remains highly original with just one professional repaint, and the underside is unrestored. This "Ed Meyer-approved" Boss consistently scores high in national concours events and it is now offered complete with a Marti report and original documentation. Simply put, it is an outstanding example of a first-year Boss 429 and a historic race-bred factory supercar.

The COPO or Central Office Production Order system was the mechanism where General Motors took special orders for police cars, school buses, and fleet vehicles like taxicabs. Estimates should not be relied upon, and each bidder and Buyer hereby agrees not to rely upon any estimate, as a fact of guarantee or prediction of the actual selling prices or value of a Vehicle, and Russo and Steele shall not have any liability with regard to any estimates under any circumstances.

RESERVES

Unless otherwise specified in the catalogue or announced at the Auction, the Vehicles will be offered subject to a reserve, which is the minimum amount that the seller is willing to accept with regard to the respective Vehicle. Reserves are confidential and will not exceed the low presale estimate. Russo and Steele may act to protect the reserve by bidding through the Auctioneer, who may open bidding below the reserve by placing a bid on behalf of the seller, place bids on behalf of the seller up to the reserve amount, place bids in response to other bidders or if the opening bid is below the reserve can elect to withdraw the Vehicle from bidding. The Auctioneer shall not be obligated to specifically identify bids placed on behalf of the seller to protect the reserve nor will he place a bid on behalf of the seller at or above the reserve. Sellers may not bid on Vehicles they have consigned to Russo and Steele without announcement at the Auction.

AUCTIONEER'S DISCRETION/ BIDDING DISPUTES

The Auctioneer, in his sole discretion, has the right to refuse any bid and to split of advance bidding in increments as he may choose, regardless of any increment parameters set forth in this catalogue or otherwise. The Auctioneer has the final say in the event of concern or doubt by the Auctioneer about the validity of any bid, any error relating to bidding or any bid (including, but not limited to , error by the Auctioneer or Russo and Steele), or any dispute between bidders. The Auctioneer may choose, in his sole discretion, including, but not limited to, in the event of concern, error, dispute jor doubt with regard to any bid or bidding, to continue bidding, refuse a bid, cancel a bid, determine the successful bidder, withdraw a Vehicle, reoffer a Vehicle, reopen bidding or restart the bidding, as the case may be. In any dispute, Russo and Steele's records, whether audio, visual or written, are conclusive. Once made, a bidder may not retract or rescind any bid.

THE BUYER

The buyer ("Buyer") is the highest bidder acknowledged by the Auctioneer and accepted by Russo and Steele, subject to the reserve, if any, and the terms of these Conditions of Sale. The fall of the Auctioneer's hammer marks the acceptance of the Buyer's bid and a contract of purchase

and sale is made between the Buyer and seller. Russo and Steele is not a party to the contract of purchase and sale and Russo and Steele shall not be liable or responsible for any breach or default of such contract by either Buyer or seller. Subject to the General Conditions, including, without limitation the Buyer's fulfillment of Buyer's obligations and covenants under these Conditions of Sale, title to the specified Vehicle shall pass to the Buyer when the full Purchase Price (as defined below) is paid in accordance with these Conditions of Sale. Upon the fall of the hammer, the Buyer is thereupon responsible for and assumes all risk of loss or damage to such Vehicle. Russo and Steele, its employees, officers, directors, agents and representatives shall not be liable for any loss or damage to or any loss or damage caused by any Vehicle at any time. Immediately following the fall of the hammer, the Buyer shall be required to execute a Confirmation of Purchase, which confirms Buyer's purchase of the Vehicle as announced by the Auctioneer. Whether or not the bidder is acting as an agent, unless Russo and Steele is notified in writing by the principal in advance of the Auction that the bidder is acting as an agent for the principal and Russo and Steele accepts in writing in its discretion such notice, the bidder shall be deemed personally responsible for payment in full of the Purchase Price as Buyer and for fulfillment of Buyer's obligations and covenants under the General Conditions. All sales are final. No person shall be entitled to bid or shall bid at the Auction unless they have complied with the requirements of the General Conditions, including, without limitation, registering in advance with Russo and Steele by completing all such registration and other forms and providing financial and other information as Russo and Steele in its discretion may request or require.

PAYMENT

The purchase price to be paid by the Buyer is, and the Buyer acknowledges it is, responsible for an agrees to timely pay, the sum of the final bid price (the highest bid acknowledged and accepted by the Auctioneer), plus the Buyer's premium of 10% of the final bid price, plus all applicable state and local sales and/or use tax and license fees, plus any and all costs and expenses incurred on behalf of the Buyer and/or as a result of the Buyer's failure to timely and fully comply with the General Conditions, including, but not limited to, removal, transport and storage costs for the Vehicle and taxes thereon, plus all other amounts due and owing pursuant to the General Conditions (collectively, the Purchase Price). Payment of the full Purchase Price is due to Russo and Steele on or before 5:00 pm local time of the Auction location on Monday, August 19, 2013. Russo and Steele reserves the right to impose a late charge of up to a maximum of 18% per annum (or the maximum rate permitted by law if less than 18%) on any portion of the Purchase Price if the buyer does not make timely payment of the Purchase Price when due under these Conditions of Sale. All payments must be made by wire transfer. Unless otherwise agreed to by Russo and Steele in writing, Russo and Steele will not accept payment of any portion of the Purchase Price from any party other than the Buyer. Title to a Vehicle does not pass to the Buyer, and the Vehicle will not be released to a Buyer, until good and cleared funds in the amount of the full Purchase Price are received by Russo and Steele in accordance with the General Conditions.

COLLECTION, REMOVAL AND STORAGE

Buyer must comply with all of the General Conditions, including, but not limited to, Russo and Steele shall have received payment in full, in good cleared funds, of the Purchase Price, and all Vehicles must be removed from the Auction site at Buyer's risk and expense, by 5:00 pm local time of the Auction location on Tuesday, August 20, 2013. If not removed timely by Buyer, in addition any and all other remedies and rights Russo and Steele may have, Russo and Steele shall have the right (but not the obligation) to removed any Vehicle at Buyer's sole risk and expense and store it, at Buyer's account, including, without limitation, removal, storage, transportation and handling expenses and costs and applicable taxes, at a third-party warehouse, and Buyer hereby grants Russo and Steele an irrevocable power of attorney to remove and store such vehicles at Buyer's expense. Except in Russo and Steele's sole discretion, no Vehicle shall be released to Buyer until Russo and Steele has received payment in full, in good cleared funds, of the Purchase Price for the Vehicle, and Buyer has fully complied with the General Conditions.

ROADWORTHINESS/COMPLIANCE

Notwithstanding any verbal or written statement or description of any kind regarding any Vehicle, whether by or on behalf of Russo and Steele or seller, including, without limitation, in the catalogue for the Auction, all Vehicles are sold "as is" and only as collector's items and Vehicles may not be suitable for use on the road. The Buyer of any Vehicle who intends to use the Vehicle on the road is responsible for determining roadworthiness and for complying with all applicable regulations regarding title, registration, insurance, emission control, safety equipment and the Buyer assumes all risk of whether any such Vehicle will or does comply, and neither Russo and Steele nor the seller shall have any liability or responsibility of any kind for failure to comply or lack of roadworthiness by any Vehicle.

EXPORT PERMITS

The Buyer is responsible for determining whether or not an export permit is required to export a Vehicle and for obtaining and paying the costs of any permits or licenses necessary to export

any Vehicle from the United States and/or import it into any other country, and for the payment of any import duty that may be levied by the country of import. Russo and Steele makes no representation or warranty of any kind with regard to whether or not and Vehicle and be exported or imported or the issuance of an export or import permit for any Vehicle.

RELEASE

By attending the Auction, each attendee grants all necessary rights to Russo and Steele and agrees that Russo and Steele has permission and license to use his or her likeness for television, video, still photography and/or any other visual/audio recording, display, transmission, broadcast and/or publication for any and all purposes (including, without limitation, advertising and marketing) at any time or times, including, without limitation, concurrent with and/or subsequent to the Auction, waives all rights or claims (including, without limitation, residual rights and rights of privacy and publicity) that might arise from use of the bidder's image, voice, picture or likeness for any purpose, including, without limitation, at any future date, under all applicable laws, including, without limitation, common law or by statute, and agrees that admission onto the Auction site constitutes full and express acceptance of the above terms and conditions.

RUSSO AND STEELE'S RIGHTS

Russo and Steele reserves the right, in its sole discretion, to (a) withdraw any Vehicle at any time prior to or at the Auction, (b) postpone or cancel the Auction of any or all of the Vehicles for any reason and/or (c) reject or refuse any bid from any party before or during the Auction. Each bidder and/or Buyer agrees that Russo and Steele shall not have any liability whatsoever to any bidder for exercise of any of the foregoing rights, or for any errors in execution or failure to execute any bid(s), regardless of circumstances or events of any kind.

NONCOMPLIANCE OF BUYER/ REMEMDIES

If the Buyer or bidder fails to comply with any of the General Conditions, including, without limitation, a Buyer or bidder fails to timely pay the full Purchase Price and/or remove a Vehicle when and as required by these Conditions of Sale, the Buyer or bidder, as the case may be, shall be in breach and default of the General Conditions, and shall be liable to Russo and Steele, and each bidder and Buyer agree that Russo and Steele shall be entitled to recover from such Buyer or bidder, as the case may be, any and all damages, costs, expenses, fees (including attorneys' fees) and other amounts suffered and/or incurred by Russo and Steele as a result of such failure to comply (including, without limitation, any such damages, costs, expenses, fees and other amounts suffered or incurred as a result of suit(s) by the seller or other third parties). Further, in such event of a failure to comply, Russo and Steele may, in its sole discretion, at any time and from time to time, in addition to all other available remedies under the General Conditions, at law and otherwise, and without any notice to such Buyer or bidder, take any one or more of the following actions to fullest extent allowed by law (a) hold the defaulting Buyer or bidder, as the case may be, liable for the Purchase Price and all damages, costs and expenses suffered or incurred by Russo and Steele as a result of such default and failure to comply, including, but not limited to, initiating legal action against the Buyer or bidder, including, without limitation, an action for specific performance; (b) cancel or rescind the sale; (c) resell the Vehicle(s) with or without reserve privately or at public Auction and the Buyer or bidder shall be liable for any deficiency between the Purchase Price (plus all damages, costs, expenses, fees [including attorneys' fees] incurred by Russo and Steele as a result of noncompliance and all commissions, premiums and fees applicable to such resale's) and the price received upon the resale; (d) remove or arrange for the removal and storage of the Vehicle at the sole risk and cost of such defaulting Buyer or bidder; (e) offset any sums due from Russo and Steele to the Buyer or bidder against the Purchase Price and all other amounts due and owing by the Buyer or bidder under the General Conditions; (f) repossess the Vehicle(s) for which the Purchase Price or any portion thereof is unpaid, and resell such Vehicle(s) and apply sale proceeds against amounts owed by such Buyer or bidder under the General Conditions; and/or (g) take any other action that Russo and Steele in its sole discretion deems necessary or desirable, including any combination of the foregoing remedies. If Buyer or bidder has purchased more than once Vehicle and Russo and Steele receives less in payment than the total due for all Vehicles purchased, Russo and Steele shall, in its sole discretion, apply the funds received toward payment of whichever Vehicle(s) it determines, regardless of what the Buyer or bidder may or may not direct. Each Buyer and bidder by registering to bid or by placing a bid at the Auction hereby agrees to grant Russo and Steele and Russo and Steele shall be deemed to have first priority security interest in, and Russo and Steele may retain as collateral security for such Buyer's or bidder's obligations to Russo and Steele, any Vehicle and any other property in Russo and Steele's possession owned by such Buyer or bidder and any and all proceeds (including proceeds as defined under the Uniform Commercial Code in effect in California), including insurance proceeds, of any of the foregoing. Russo and Steele shall have all the rights and remedies provided to a secured party under the UCC and shall been entitled to file one or more financing statements as Russo and Steele may desire, with regard to any and all such Vehicles and other personal property, and shall be entitled to sell any such property in Russo and Steele's possession and apply against the Purchase Price and other



amounts due and owing by the Buyer or bidder and the proceeds from such sale. If Buyer or bidder defaults and Russo and Steele elects, which it may do in its discretion, to pay the seller a portion of the net proceeds due seller with regard to the sale of the Vehicle, Russo and Steele shall have all the rights and remedies of seller against the Buyer or bidder, including, without limitation, the right to pursue the Buyer or bidder for all such amounts and any and all other amounts, damages, costs, fees and expenses as may be available under the General Conditions, at law, in equity or otherwise.

JURISDICTION

The Auction, the General Conditions and the relationship and rights and obligations of the parties shall be governed solely and exclusively by the laws of the state of California, without regard to such state's choice of law rules and regardless of where the bidder or Buyer is located or received any Auction materials. Each bidder and Buyer agree that any dispute (including any claim, counterclaim or other action) arising with regard or relating to any of the General Conditions, the Auction or any Vehicle shall be brought and adjudicated only in the Los Angeles Superior Court or the United States District Court for the Central District of California, to the exclusion of all other venues and jurisdictions, and each bidder and Buyer, by registering to bid at or participating in the Auction (whether in person , through an agent or representative, by absentee bid or telephone bid), and any person attending the Auction, hereby agrees to and does submit and consent to exclusive jurisdiction in such courts and hereby agrees to and does submit and consent to personal jurisdiction of any and all such courts in California.

BINDING ON SUCCESSORS

The General Conditions shall be binding on each attendee or participant, as the case may be, in the Auction, and each bidder and Buyer and Russo and Steele, and their respective agents, heirs, executors, legal representatives, successors and assigns.

ATTORNEYS' FEES

If Russo and Steele engages council to assist it to enforce any part of the General Conditions, with regard to any bidder, attendee, Buyer or other party, such bidder, attendee, Buyer or other party, as the case may be, shall be responsible for all reasonable fees (including, without limitation, attorneys' fees), costs and all expenses incurred by Russo and Steele (including, without limitation, costs and all expenses related to evaluating, analyzing, assessing, enforcing, preparing for and conducting litigation of any kind or nature), whether or not legal proceedings are commenced. If proceedings are initiated with regard or relating in any way to or arising out of the General Conditions, any Vehicle, and/or the Auction, the prevailing party shall recover its reasonable attorneys' fees, costs and expenses; provided, however, and notwithstanding the foregoing, if a bidder, attendee, Buyer or other party fails to first present any claim directly to Russo and Steele and allow for a reasonable opportunity and period to mediate (and participate in such mediation of) such claim before initiating legal action against Russo and Steele or any of its officers, directors, employees, agents or representatives, then such bidder, attendee, Buyer, or other party as the case may be, shall not be entitled to recover on any such claim any attorneys' fees whether or not such bidder, attendee, Buyer or other party prevails on such claim.

LIMITATION ON DAMAGES

EACH ATTENDEE AT THE AUCTION AND EACH BIDDER AND BUYER BY ATTENDING OR PARTICIPATING IN THE AUCTION WHETHER IN PERSON, THROUGH AN AGENT OR REPRESENTATIVE, BY TELEPHONE BID OR ABSENTEE BID AGREES THAT (A) ANY CLAIMS RELATING TO THE AUCTION, SALE OF A VEHICLE OR THE GENERAL CONDITIONS MUST BE FIRST PRESENTED DIRECTLY TO RUSSO AND STEELE BEFORE FILING A LEGAL ACTION, AND (B) RUSSO AND STEELE SHALL NOTHAVE ANY LIABILITY TO ANY ATTENDEE, BIDDER, BUYER OR OTHER PARTY FOR INJURY OR DAMAGE OF ANY KIND RESULTING FROM OR RELATING TO THE NEGLIGENCE OF RUSSO AND STEELE OR ANY OF ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS OR REPRESENTATIVES, ACTIVE OR OTHERWISE, OR RELATING IN ANY WAY TO ANY VEHICLE(S) OR THE AUCTION OR ANY ACT OR OMISSION OF ANY OF THE FOREGOING, UNLESS RUSSO AND STEELE OR ITS EMPLOYEES, OFFICERS, DIRECTORS, AGENTS OR REPRESENTATIVES ARE GROSSLY NEGLIGENT AND RUSSO AND STEELE'S SOLE LIABILITY AND DAMAGES, AND EACH ATTENDEE'S, BIDDER'S, BUYER'S AND OTHER PARTY'S SOLE AND EXCLUSIVE REMEDY, IF ANY, AT LAW, UNDER THE GENERAL CONDITIONS AND OTHERWISE ARISING OUT OF OR DIRECTLY OR INDIRECTLY RELATING IN ANY WAY TO THE AUCTION, ANY VEHICLE(S) (INCLUDING, BUT NOT LIMITED TO, ANY INABILITY TO DELIVER POSSESSION OF A VEHICLE TO THE BUYER). BIDDER OR BUYER ARE NOT SUFFICIENT TO WARRANT RUSSO AND STEELE ASSUMING ANY RISK OF DAMAGES OF ANY KIND, INCLUDING, BUT NOT LIMITED TO, CONSEQUENTIAL DAMAGES TO THE BIDDER, ATTENDEE OR BUYER AS A RESULT OF OR RELATING TO ANY NEGLIGENCE, BREACH OR FAILURE TO


